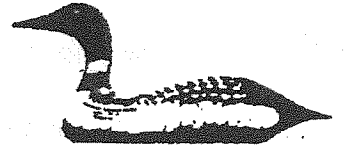

**Requirements: R707 & 1510 NYS Building Code Recovering Versus Replacement of existing roofs. New roof coverings shall not be installed without first removing existing roof coverings where any of the following conditions exist:**

1 Where existing covering is water-soaked or has deteriorated to the point that the existing roof covering is not adequate as a base for additional roofing.

2 Where existing roof covering is wood shake, slate, cement or asbestos-cement tile.

3. Where existing roof has two or more applications of any type of roof covering.
