SUPERVISOR'S REPORT

Expenditure and Revenue Reports were in the Board's packets for review.

Shaw Brook Project- Paula Bagley of the USDA NRCS spoke with Matt Newby and said the next step of the Brook rehabilitation is having their Archeologist visit the site for a Cultural Resource Survey. Lenny Croote of Hamilton County Soil and Water, Councilman Donnelly, Paul Wilson, Matthew Newby, and Supervisor Arsenault went to visit the site at the beginning of May. Councilman Donnelly suggested to bid out the job of removing, grinding, and disposing of the large piles of trees. Once the cultural resource survey is done and Mr. Croote completes his project plan, a bid packet will be drawn up.

Jennings Park Pond- After months of research and legal counsel, the Town Board has determined that Mr. Carrothers is the fee title owner of Pine Island, the causeway and half of Middle Island. Mr. Carrothers has presented a written offer for the Town to purchase some of the property containing the failed causeway at \$160,000. The Board plans to work out a solution based on the offer and will have a finalized deal worked out as soon as possible.

DANC and CHA will be meeting with the Supervisor and his staff on June 6th to discuss the reconstruction project of Jennings Park Pond.

Rescue Squad- The Long Lake Rescue Squad has moved to the Long Lake Fire Department on South Hill, the old building will be used as storage for the Long Lake Fire District.

APA Permits- The Town has received two permit notifications from the APA. The first permit is for Fishing Brook Bridge, the State will be finishing up the project and removing the temporary bridge landing and fix the Brook. The second permit is a Notice of Major Project for the new NYSEG substation in Raquette Lake. NYSEG will be moving their substation across the road onto a portion of property that was owned by George Moore. The notice said that the APA is formally reviewing the project now that the application has been found to be complete.

Town Sole Assessor has included in the Board's packets a grievance day report.
