SUPERVISOR'S REPORT

Expenditure and Revenue Reports were in the Board's packets for review.

Sidewalk project-NYS DOT is planning a major road project through Long Lake in 2026, they asked if the Town would be willing to give the TAP/CMAQ Sidewalk Project Grant award to them and they would take on the responsibility and additional costs of the sidewalk project. They have offered to rebuild the retaining wall along the Town ballfield as part of the project. This will be discussed during the Town budget workshops.

Speed limits- the Reiss family wrote a letter concerning the speed limits on State roads within the hamlet of Long Lake. Supervisor Arsenault has contacted Jacob Olds the NYS DOT Traffic Safety Engineer and asked him to consider what the residents perceive as a safe speed limit. Lake Champlain Lake George Regional Planning Board is also conducting a Traffic Safety Study of our region.

Town Highway September report was in the Board's packets for review.

CHA- Town engineering company CHA conducted a water needs assessment with Keith Austin Water Dept. Head. This assessment will aid the Town in budgeting and planning for water system improvements.

CHA provided a proposal for their architectural team to design a new municipal building that will have the court, town offices, and visitors center combined. This design will not be started for a few years. CHA sent their revised sediment removal plan for Jennings Park Pond; this plan is not set to start yet due to all the work with FEMA that needs to be done.
